PARTICIPATION AGREEMENT, RELEASE AND ACKNOWLEDGEMENT OF RISK

This waiver and release covers all USA Bass Trails LLC events. All contestants must sign this waiver prior to participating in a USA Bass Trails LLC event. In condition of USA Bass Trails LLC allowing me to participate, I acknowledge and agree as follows:

1. I have read and understand the description of the event and the official rules. I will obey all rules and understand that any violation may result in immediate disqualification without refund of my entry fee. I also understand that event officials may reject my application for any reason and in that event will refund my event entry fee.
2. I understand and acknowledge that competitive fishing is a dangerous sport, the risks of which include, though not exclusively, drowning, and collisions on or in the water, injuries from hooks and other fishing paraphernalia. I voluntarily assume responsibility for these risks, identified and not identified, and all risk of injury or death or damage to myself or my property or to others arising from my participation in the event.
3. I hereby release, discharge, and agree to hold harmless and indemnify USA Bass Trails LLC, its shareholders, officers, directors, agents and employees, the host, sponsors and event officials, and its partners, agents or employees, and all other person or entities associated with the event from any and all liability, claims, demands, actions or rights of action which are related to, arise out of, or are in any way connected with my participation, including specifically, but not limited to the negligent acts or omissions of USA Bass Trails LLC, its shareholders, officers, directors, agents or employees, the host, sponsors and event official, and its partners, agents or employees and all other persons or entities associated with the event for any and all injury, death, illness or disease, and other damage or loss to property suffered by myself or others.
